Special Notes:

- For some approvals the exact date of approval was not listed. In those cases the year it appeared in the Proceedings was used as the year of approval, however, this occurred during the time that the annual year actually split between two years so the exact year is not known.
- Numbers with letters were either all approved the same year with no order clearly identified or actually approved at the same meeting as indicated by the date approved. If only the year was known then they are listed in the order as printed in the Proceedings.
- Other lodges may have been approved or denied but no other records have been found to confirm specific actions by the Board of Custodians. If a lodge has such records they can contact the Secretary of the Board and they will be added to this list.
